### Murder of the Unborn and After Birth

#### Pro-abortion California bill could legalize infanticide for months after birth, attorney warns

AB 2223 'is beyond the pale for any civilized society to even consider, and must be aggressively opposed by all people of conscience who value human life.'

SACRAMENTO ([LifeSiteNews](#)) — A gruesome new pro-abortion bill proposed in California could legalize infanticide for weeks, months, or even years after a child is born, an attorney with the Thomas More Society told LifeSiteNews.

[AB 2223](#) was introduced in February as a placeholder for future legislative language amid a raft of pro-abortion proposals advanced by lawmakers, following radically pro-abortion Democrat Gov. Gavin Newsom’s promise to make California a “sanctuary” for abortion, Right to Life League [reported](#).

On March 17, the bill’s authors submitted updated language to amend existing state laws.

**“AB 2223 literally decriminalizes infanticide -- the killing of babies possibly up to two months old. It eliminates civil and criminal penalties for abortions including "perinatal death." The bill doesn't define the term “perinatal”**

Under the new language, a “person shall not be subject to civil or criminal liability or penalty, or otherwise deprived of their rights, based on their actions or omissions with respect to their pregnancy or actual, potential, or

alleged pregnancy outcome, including miscarriage, stillbirth, or abortion, or perinatal death.” [*Internet: Prenatal, relating to the time, usually a number of weeks immediately before and after birth.*]

Thomas More Society Special Counsel Charles LiMandri, [a partner at LiMandri and Jonna LLP](#) who earned his law degree at Georgetown University in Washington, D.C., told LifeSiteNews in an email Saturday that the altered language would allow for “the brutal murder” of babies weeks, months, or even years “after they are born.”

According to LiMandri, the proposal “exposes the false narrative that the abortion lobby has been peddling for over half a century: That no one knows when life begins, and babies in their mothers’ wombs feel no pain. No sane person can deny that a newborn infant is a fully developed human being, one that is capable of feeling intense pain. Yet, by including ‘perinatal’ in its provisions, [the bill] would authorize the brutal murder of these infants even after they are born.”

LiMandri, an author and lecturer who has appeared and been published nationally and internationally, noted that the definition of the term “perinatal” varies, spanning weeks or even years after an infant is born.

He cited MedicineNet [which puts](#) the definition of “perinatal” at ending “1 to 4 weeks after birth,” as well as the government definition of the phrase via PubMed.gov, [which states](#): “The perinatal period, broadly defined, encompasses the time frame from ... 18 to 24 months after the birth of the child.”

“Hence, [AB 2223] leaves one to ask: ‘What kind of depraved monsters would justify the killing of innocent and helpless children between one week and two years after their birth?’” LiMandri said.

According to LiMandri, the radical legislative proposal “is beyond the pale for any civilized society to even consider, and must be aggressively opposed by all people of conscience who value human life.”

The attorney also pointed out the legislation, if approved, “would violate the federal ‘Born-Alive Infants Protection Act’ of 2002, that extends legal protection to an infant born alive after a failed attempt at induced abortion.”

The Born-Alive Infants Protection Act [was signed into law](#) in 2002 by President George W. Bush and “[d]irects that in determining the meaning of any Act of Congress or of any ruling, regulation, or interpretation of the various U.S. administrative bureaus and agencies, the words ‘person,’ ‘human being,’ ‘child,’ and ‘individual’ shall include every infant member of the species homo sapiens who is born alive (as defined in this Act) at any stage of development.”

In addition to violating the 2002 federal law protecting babies born alive after botched abortions, LiMandri told LifeSiteNews the California proposal “also violates Article 1, Section 1, of the California Constitution, which provides that: ‘All people are by nature free and independent and have inalienable rights. Among these are enjoying and defending life and liberty, acquiring, possessing, and protecting property, and pursuing and obtaining safety, happiness, and privacy.’”

“Therefore, if this evil Bill were to become law, we would immediately attack and defeat it [in] the courts,” LiMandri said.

This isn’t the first or only radical pro-abortion bill introduced in California in recent weeks.

On Tuesday, Gov. Newsom [signed legislation](#) to make abortions free in the Golden State by bulldozing out-of-pocket costs for abortion services covered under health insurance plans.

“With this legislation, we’ll help ensure equitable, affordable access to abortion services so that out-of-pocket costs don’t stand in the way of receiving care,” Newsom said in a statement.



Last week, Democratic state Sen. Nancy Skinner of California proposed a bill to create a fund for low-income Californians and women traveling from pro-life states like Texas to abort their unborn babies.

[According to Skinner’s Senate webpage](#), “SB 1142 would establish a first-of-its-kind fund composed of state and philanthropic dollars that would significantly increase funding for abortion services for low-income Californians and for out-of-state residents who may come here for an abortion.”

The moves come after Newsom [promised](#) California would be a “sanctuary” for abortion as numerous right-leaning states throughout the country have enacted laws restricting or banning the procedure.

Last year, Republican Gov. Greg Abbott signed the [Texas Heartbeat Act](#) into law, banning abortions after about six weeks gestation in the Lone Star State, sparking copycat legislation and generating national controversy. The life-saving law, which has reportedly [reduced Texas abortions by 60%](#), has so far been upheld by both the [Texas Supreme Court](#) and the [U.S. Supreme Court](#).

On Wednesday, Idaho Gov. Brad Little [signed a law](#) modeled after the Texas law banning abortions at around six weeks gestation.

Battles over pro-life and abortion legislation have ramped up in recent months in anticipation of the U.S. Supreme Court’s ruling in *Dobbs v. Jackson Women’s Health Organization*. The crucial case currently on the Supreme Court docket concerns Mississippi’s 15-week abortion ban and could see the federal “right to abortion” overhauled or overturned this summer, permitting pro-life states to severely restrict or even ban abortion outright. 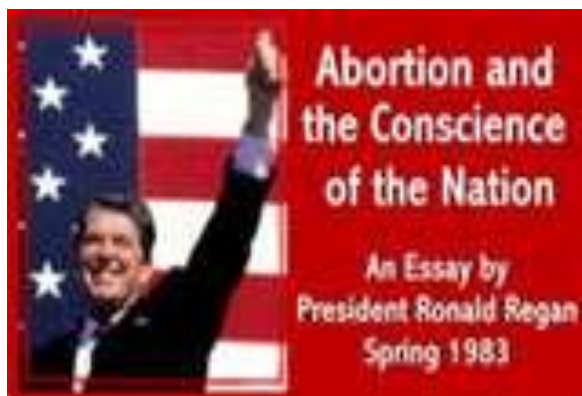

**President Reagan's essay, "Abortion and the conscience of the nation"...**



*The following article was written by President Ronald Reagan in the spring of 1983:*

"The 10th anniversary of the Supreme Court decision in *Roe v. Wade* is a good time for us to pause and reflect. Our nationwide policy of abortion-on-demand through all nine months of pregnancy was neither voted for by our people nor enacted by our legislators— not a single state had such unrestricted abortion before the Supreme Court decreed it to be national policy in 1973.

But the consequences of this judicial decision are now obvious: since 1973, more than 15 million unborn children have had their lives snuffed out by legalized abortions. That is over ten times the number of Americans lost in all this nation's wars.

Make no mistake, abortion-on-demand is not a right granted by the Constitution. No serious scholar, including one disposed to agree with the



Court's result, has argued that the framers of the Constitution intended to create such a right.

Shortly after the *Roe v. Wade* decision, Professor John Hart Ely, now Dean of Stanford Law School, wrote that the opinion "is not constitutional law and gives almost no sense of an obligation to try to be."

Nowhere do the plain words of the Constitution even hint at a "right" so sweeping as to permit abortion up to the time the child is ready to be born. Yet that is what the Court ruled.

As an act of "raw judicial power" (to use Justice White's biting phrase), the decision by the seven-man majority in *Roe v. Wade* has so far been made to stick.

But the Court's decision has by no means settled the debate.

Instead, *Roe v. Wade* has become a continuing prod to the conscience of the nation.

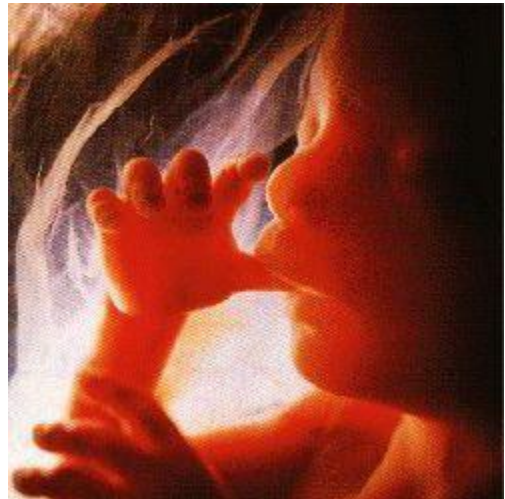
Abortion concerns not just the unborn child, it concerns every one of us.

The English poet, John Donne, wrote: "... any man's death diminishes me, because I am involved in mankind; and therefore, never send to know for whom the bell tolls; it tolls for thee."

We cannot diminish the value of one category of human life— the unborn— without diminishing the value of all human life.

We saw tragic proof of this truism last year when the Indiana courts allowed the starvation death of "Baby Doe" in Bloomington because the child had Down's Syndrome.

Many of our fellow citizens grieve over the loss of life that has followed *Roe v. Wade*.



Margaret Heckler, soon after being nominated to head the largest department of our government, Health and Human Services, told an audience that she believed abortion to be the greatest moral crisis facing our country today.

### ***Life Begins at Conception***

Both the born and the unborn are alive, for life *begins* at conception! The only difference is that one has already entered the world with its life intact; and the other will have its life taken away before it is born, *and sometimes after!*

*News articles have also made known selling and using all of the dismembered parts of the unborn and born is big business. They are used in many different ways in society. One could equate this to cannibalism.*

## **A 21Week-old Baby**

**Joseph Bruner while still inside the mother's womb.**

As Dr. Bruner completed the surgery on little Samuel, the little guy reached his tiny, but fully developed hand through the incision and firmly grasped the surgeon's finger. "An amazing picture began circulating in November, 03 of a 21-week-old baby, named Samuel Alexander Armas, being operated on by a surgeon named Dr. Bruner.**

**In a Time Europe article highlighting new pregnancy imagery that show the formation of major organs and other significant evidence of human life after conception, Dr. Bruner was quoted as saying that when his finger was grasped, it was the most emotional moment of his life, and that for an instant during the procedure he was just frozen, totally immobile.**

**The photograph captures this amazing event with perfect clarity. The editors titled the picture, 'Hand of Hope.'**



**explaining the picture begins, 'The tiny hand of 21-week-old fetus Samuel Alexander Armas emerges from the mother's uterus to grasp the**

finger of Dr. Joseph Bruner as if thanking the doctor for the gift of life.’

**Little Samuel’s mother said they ‘wept for days’ when they saw the picture. She said, ‘The photo reminds us my pregnancy isn’t about disability or an illness, it’s about a little person.’ Samuel was born in perfect health, the operation 100 percent successful.**

### ***Partial Birth***

Carrying the unborn baby to full term, and then aborting, is called – *partial birth* – meaning after the body of the baby is born, and its little head is still inside the womb it is then *murdered!* It is at this point that the one doing the abortion reaches inside the womb and *punctures* the back of the baby’s skull and *sucks* the brains out before it can be born!

One can better understand the callousness of this terrible act when it is realized that the sacrificial murder of her unborn baby is mainly due to the worship of her own body! Loving her own desires more than the life she has forcibly removed from her body! This means such women worship themselves!

God labels the taking of a human life as ***murder*** whether born or unborn (*Exodus 20:13; 21:22-23*).

With little *unborn* Samuel in mind, who reached out and wrapped his little fingers around the doctor’s finger, with hope for life, one cannot help but wonder how many millions of unborn children have reached out with their little hands trying to find someone who would care enough to spare them from an *excruciating, painful* death and make possible life for them outside their mother’s womb?

*This is too horrible to even think about.*

One cannot help but wonder how doctors and nurses who are involved in performing these abortions are able to live with themselves without feeling terrible pangs of remorse? The answer seems to be that their conscience has become so seared from killing these little ones it does not bother them that much, *if any at all!*

It should be emphasized that liberal lawmakers in Congress continue to do all they can to keep from nominating judges from serving on the Supreme Court of the United States who are against a woman's right to have abortions. And there are enough of them who do have such a loud voice they rarely have little real opposition.

Some few years ago it was said on the news that one of the most vocal leading senators for abortion rights, Senator Ted Kennedy, planned on writing a book about little children! Can we imagine such a thing? In any case it never happened. He died.

We are truly living in very sorrowful and hypocritical times.

***Slouching Towards Gomorrah, Page 180, Judge Robert Bork: "But it is clear, in any event that the vast majority of all abortions are for convenience. In those cases, abortion is used as merely one more technique of birth control. A 1987 survey of the reasons given by women for having abortions, made by researchers with the Alan Guttmacher Institute, which is very much pro-abortion, demonstrated this fact."***

Convenience is another word for the act of *vanity and selfishness*, thinking only of self. It is evident there is no real caring thought to the little precious life within her body!

## The **Fire** of Painful Deaths

Those who have experienced the terrible and excruciating pain from a real



*burn* to the flesh can understand to a small degree what the *babies* experienced while being roasted to death in the **red-hot heated arms** of the pagan idol, Molech! Terrible anguished pain was experienced by them for they did not die immediately!

Because of *not* seeing or hearing the anguished cries of the unborn babies as they are being murdered, people do not want to believe they have no real life inside the womb, and further— that they feel no pain while they are being murdered.

This is what Governor Newsom and the lawmaking bodies in Sacramento, California are now sponsoring a bill that would murder the unborn before and after as the news article makes known. At the same time making this state a sanctuary, with expenses paid for those seeking abortions from other states who have passed laws against abortion after a few weeks.

The governor has children of his own. And probably others of these law-making bodies have children as well. Estimates are 3 out of 10 conceptions end in the very painful death of the fetus!

## Marjorie Taylor Greene calls for investigation into dead babies recovered by pro-lifers in DC

'The slaughter of innocent children is of course the logical endpoint to the Left's culture of death,' Greene said

[LifeSiteNews](#)) — Republican Congresswoman Marjorie Taylor Greene has called for a full investigation into the possible infanticide of five dead

babies recovered by pro-life activists in Washington, D.C.

“In our nation’s capital, five dead babies were delivered to police by a pro-life activist, Lauren Handy,” Greene said in a [video](#) posted to social media on Tuesday.



Last week, the remains of five infants were delivered to DC Metro police in a condition consistent with partial birth abortion or infanticide. I'm calling for a full medical examination and police investigation to determine when and how these innocent babies died.

“The babies were intact, suggesting that they had been delivered alive. One of them had her skull crushed and her brain removed in a manner consistent

with partial birth abortion, or infanticide,” added the representative from Florida.

Greene explained that despite the evidence that the babies were killed in illegal partial birth abortions, D.C. Metro police have said that “no murder investigations have been opened” as an initial inquiry shows the babies were killed in “accordance with D.C. law.”

“This is absurd. The American media, consumed with Joe Biden’s ‘Trans Day of Visibility,’ has been shamefully silent. The slaughter of innocent children is of course the logical endpoint to the Left’s culture of death,” stated Greene.

“Since baby killing activists are now brazen enough to advocate for infanticide, it is right to ask if these infants were a victim of this new and bloodthirsty zeal of the deaths of innocents,” added Greene, referencing California’s proposed AB2223 bill which if passed, allows for “perinatal” abortion.

In an [interview](#) with LifeSiteNews’ John-Henry Westen on Tuesday, Handy, the pro-life witness who found the remains of the five infants, explained that she took them from a medical waste worker in order to give the children a proper burial.

In Handy’s heartbreaking interview, she explained how the unpacking of the babies’ bodies from medical waste boxes was the “most soul-crushing experience” she’s ever had in her life.

“I kept saying to myself, ‘I’m sorry, baby. I’m sorry. I love you,’” Handy recalled to Westen.

“I’ve already dedicated my life to helping these babies, but I have never seen such horror, such violence, such hatred for our fellow man. And I can’t unsee it. And it’s haunted me every second of the day since that moment.”

Handy and [eight other pro-life activists](#) were arrested and [charged by the FBI](#) last week for leading a “traditional rescue” at a Washington, D.C., abortion mill in October 2020. Handy and the others are now facing up to 11 years in prison, three years of supervised release, and \$350,000 each in fines.

## Skilled Wording Hides the True Facts

This Scripture makes very clear the fact that whether born, or unborn, these babies belong to God. They are intended by Him to be on loan, so-to-speak, to their parents to rear for Him.

### *We Reap What We Sow*

Speaking to John Lovell on the Warrior Poet Society podcast, Cawthorn was asked if *House of Cards*, the show starring Kevin Spacey as the Democratic chief whip and his “secret life of corruption and power and money and perversion,” was anything to close to the reality of what goes on in Washington DC.

Cawthorn said he was astonished at the levels of “sexual perversion” that happen in the nation’s capital. He told Lovell that as a young guy who’s always paid attention to politics, he was shocked that some he “looked up to” throughout his life have now invited him to attend “sexual get-togethers,” which he said were actually orgies.

The House representative from North Carolina added that cocaine and drug use was rife among DC insiders. “Some of the people that are leading on the movement to try and remove addiction in our country and then you watch them do, you know, a key bump of cocaine right in front of you and it’s like, wow, this is wild,” recounted Cawthorn. Cawthorn said that there was also a “whole espionage aspect” to what happens in Washington DC.

“So many people trade in secrets, and there’s a currency to secrets,” he continued. Most disturbingly, he claimed that members of the media deliberately go after these secrets in order to “keep nasty stories about you or other people on a shelf,” ready to use as blackmail.

End of Quotes

While reading a follow up on what he said in that last paragraph has come back on him—bullying and threatening him by other Republicans, including Senator McCarthy, unless he back-tracks on what he said, and close his mouth to anything else being said about the party. Though he did admit exaggerating some, he did not deny what he had said.

**v.7 “Your country is desolate your cities are burned with fire (*Ezekiel 7:26, “disaster upon disaster”, fires, floods, etc.*); strangers devour your land in your presence (*borders wide open—illegal immigrants, millions, supported by the governments, Hosea 7:8-10*), and it is desolate, as overthrown by strangers.**

**v.9 “Unless the LORD of hosts had left us a very small remnant (*Matthew 24:22, 24; Romans 11:5, 7; Revelation 3:7-10*), we would have become like Sodom, we would have made like Gomorrah.**

**v.23 “Your princes (*implying leadership*) are rebellious and companions of thieves; everyone loves bribes and follows after**

**rewards. They do not defend the fatherless, nor does the cause of the widow come before them.**

Frightening times just ahead. **Chapter 2:19-21.**

**v.19 “They shall go into the holes of the rocks (*Revelation 6:15-17*), and into the caves of the earth, from the terror of the LORD and the glory of His majesty, when He arises to shake the earth mightily.**

The accumulated riches of many will become worthless—

**v.20 “In that day a man will cast away his idols of silver and his idols of gold, which they made, each for himself to worship to the moles and bats.**

**v.21 “To go into the clefts of the rocks and into the crags of the rugged rocks, from the terror of the LORD when He arises to shake the earth mightily.**

God then speaks of the LGBTQ throughout the tribes of Israel, including Judah, who are open and prideful about who they are, their parades, etc. **Chapter 3:9**



**v.9 “The look on their countenance witnesses against them, and they declare their sin as Sodom; they do not hide it. Woe to their soul! For they have brought evil**

**upon themselves (*Romans 1:16-32*).**

**v.10 “Say to the righteous that it will be well with them, for they shall eat the fruit of their doings (*the promise of a place of protection for the Elect, those who cry and sigh for the excruciating painful murderous deaths of the unborn and born babies—and the sick leadership and society,***

*Ezekiel 9:1-11. All this and more before the demise of the nations of Israel in the year-2026, Revelation 3:10).*

**v.11 “Woe to the wicked! It shall be ill with them for the reward of his hands shall be given him (Romans 6:23, “The wages of sin is death!”—What is sin? The transgression of God’s laws, I John 3:4).**

**v.12 “As for My people children are their oppressors and women rule over them (society is rife with women in governing positions—congress, even the vice-president, supreme court, etc.). O My people! Those who lead you cause you to err, and destroy the way of your paths.”**

### **Their End Was Preset in Ancient Times.**

Moses spoke of the following indictment to the nations of Israel that would



befall them in the end-time due to such evil among them there would be no remedy for them.

**“For I know that after my death you will become UTTERLY CORRUPT ... and EVIL will befall you in the LATTER DAYS ...”**
